<u>Mission:</u> The purpose of New Vision Academy is to provide middle school students with the skills, knowledge, and tools necessary to become active, creative, and self-motivated life-long learners.

<u>Vision</u>: The vision of New Vision Academy is to implement a "holistic" approach to educating each and every student. New Vision Academy strives to provide students with quality learning experiences while fostering critical relationship building and outreach to family members. New Vision Academy believes that regardless of a scholar's life circumstances, success can be attained.

Academic Focus and Plan: New Vision Academy (NVA) believes in "sweating the small stuff", which is incorporated every day to anticipate issues that may arise and hinder academic and social success, as well as to identify small victories that can grow into monumental gains. Our teachers and staff expect more, and in return, student performance is higher. The goal of these collective efforts is that our students take learning beyond the classroom and make it a life-long practice.

New Vision Academy provides Rigorous Academic Instruction. NVA's instruction is assessment-driven and student-centered. We provide intensive, explicit instruction while also creating ongoing opportunities to differentiate teaching and learning. Students are regularly assessed through formative and summative assessments in an interim assessment model.

Data-Driven Instruction. We assess often and are relentless about analyzing data to determine gaps, progress and instruction. Leadership has the dedicated time to support teachers on instructional and cultural priorities and teachers have the dedicated time to evaluate and action plan from weekly and cyclical data.

More Time. A strong academic foundation is first informed through the extended and prioritized use of time. The National Center on Time and Learning (2011) highlights the impact of extended, prioritized learning time focused on students' needs on all students, and particularly those with special needs.

More Literacy, More Math, More Supports. At the core of our academic program, we focus on reading, writing, and math and meeting the needs of all students. Academic Supports are based on student data and individual educational plans.

Project-Based Learning: At the core of our program is a hands-on, minds-on approach to learning that will develop students' critical thinking, creativity, problem-solving, motivation, communication and cooperation. Instead of treating each subject in isolation, we recognize that in the real world, math, science, English Language Arts, history, technology and the arts all intersect. Cross-disciplinary teacher-created projects enable students to learn via active engagement and "doing."

NVA is a **Social Emotional Learning School**. Interwoven in all we do at NVA is an emphasis on students' self-advocacy and self-actualization through high standards for student behavior, applied learning, student choice and continuous support and feedback. We emphasize self-regulation and good decision making in the pursuit of ambitious goals, helping students understand that some of the greatest learning can come from reflection on "setbacks."

School Culture. With a positive and strong school culture based on our DREAM values (Determination, Respect, Excellence, Ambition, and Mastery), middle school scholars can seamlessly transition to high school with little risk of dropping out, and have college-bound goals informed by the skills and knowledge to get them there.

Need: While there has been recent academic gains within the district and strong programs and reforms enacted by MNPS and the state of Tennessee there still exists a need and opportunity to continue to push the students in the Northwest area of Nashville to achieve at the levels required for true college preparation. There is an urgent need for high quality public schools in Northwest Nashville that is tailor made to meet the needs of the whole child, particularly in the Pearl Cohn and Whites Creek clusters. The MNPS Academic Performance Framework for 2013 illustrates that the two MNPS operated middle schools (John Early & McKissack) in the Pearl Cohn cluster are both targeted. Two of the three MNPS operated middle schools (Haynes & Joelton) in the Whites Creek cluster are targeted and the third (IT Creswell) is under review.

Targeted Population of Students: New Vision Academy- Northwest student body will be reflective of the diverse landscape of Nashville. This diversity will include students from various socio-economic backgrounds, racial and ethnic backgrounds, and educational levels. New Vision Academy- Northwest priority will be to serve those students zoned for the struggling middle schools in the Whites Creek and

Pearl Cohn clusters. As an experienced public charter middle school, our goal is to continue to offer our current students and future enrollees, who are generally at-risk for academic failure and suffering from emotional and social challenges, with a quality, comprehensive, public school education.

<u>Community Outreach Completed or Planned:</u> New Vision, Incorporated the sponsoring organization for New Vision Academy- Northwest has an extensive history of collaborating and partnering with the Nashville community. New Vision will continue to work with existing partners as well as develop collaborative partnerships with organizations in the Whites Creek and Pearl Cohn clusters.

Individual or Organizational History of Success/Accomplishments in Education: In 2001, Timothy Malone founded New Vision, Inc. New Vision is a social service non-profit in Nashville, TN. New Vision (NVI) operates under the primary goal of reducing the number of children entering the state's custody. New Vision has served over 45 counties reaching over 800 children and families yearly. In 2010, Timothy Malone and New Vision Inc. began New Vision Academy, a public charter middle school (grades 5-8), to deliver a first-rate education to at-risk students who were attending failing public schools from southeast Nashville's low-income, heavily immigrant populated neighborhoods. Under the leadership of Timothy, New Vision Academy has been recognized as a Reward School by the state of Tennessee. The only charter school in Nashville to receive this honor in 2012. New Vision Academy was once again a Reward school in 2014. We will continue to implement best practices in the services provided by New Vision, Inc. and New Vision Academy. In January of 2015, New Vision Academy gained accreditation by AdvancEd. This accreditation process aligns accreditation with accountability, emphasizing learner outcomes when evaluating institutional quality. AdvancEd is the largest community of education professionals in the world.
